Thank you for your interest in the Wednesday morning FARMERS' MARKET at Poplar Grove and the October Saturday market series.

- All **returning** vendors must submit the completed application and annual membership fee (non-refundable, payable to Poplar Grove Foundation, Inc.) ALL RETURNING VENDORS IN GOOD STANDING HAVE FIRST RIGHT OF REFUSAL BEFORE NEW SPACES ARE OPENED UP TO GENERAL APPLICATIONS. ANY RETURNING VENDORS OWING FEES FROM THE 2021 SEASON MUST FIRST PAY THEIR ACCOUNT BALANCE BEFORE BEING CONSIDERED FOR THE 2022 SEASON.
- All **new** market applicants must submit the completed application, photographs, and non-refundable \$20.00 application fee, payable to Poplar Grove Foundation, Inc. Vendors are encouraged to submit applications early as the market reserves the right to limit entries to avoid repetition. Annual membership fee is due upon acceptance.
- Please fill out the application form **completely**, including the listing of all products to be sold. **Incomplete applications will not be considered. Final acceptance/rejection may require a farm/business visit.**

Composed, constructed, and/or hand-made is defined as those artists and heritage crafts persons using a mix of concrete materials and/or ingredients to create something original based upon the core principles and foundation of the subject area.

If you are applying for Fine Arts and Heritage Crafts Vendor status, you must also read **Arts/Crafts Guidelines** on the website. All fine art and heritage crafts applications must include at least 5 examples of the items to be sold; digital photos are preferred. Email to: suzette@poplargrove.org. Examples may be required in some cases.

You will only be allowed to sell items that are specifically listed on the supplied page. Any products that are added during the year will have to be approved by the market manager prior to selling.

Full-time vendors will be designated permanent booth assignments. Please note that full-time booth assignments may or may not have space for a vehicle; please provide the approximate size of your vehicle,

plus trailer (if any, include trailer tongue) you would be selling from if such space is available_____. *applicable to farm vehicles only, spaced limited.

All vendors hereby agree to indemnify and hold Poplar Grove Foundation, Inc., its owners, employees, volunteers, directors and associates harmless from any and all claims, loss, cost, damages and other expenses, including attorneys' fees, suffered or incurred by Poplar Grove Foundation, Inc. by reason of the vendors' participation or that of its servants, agents and employees; provided that the vendors shall not be responsible nor required to indemnify the FARMERS' Market at Poplar Grove for any claims, loss, cost, damages and other expenses resulting from the sole negligence of Poplar Grove Foundation, Inc., its employees, volunteers, directors or associates.
