LOCATION: On the top grounds of Poplar Grove Plantation, nine miles north of Wilmington. Please come prepared for an **OUTSIDE SALE, RAIN or SHINE. A Halloween inspired 2 day festival featuring a vintage carnival theme and a haunted house!**

ACCEPTABLE ENTRIES:

- Select Arts and Crafts. This is a 100% HANDMADE event, upcycled items are acceptable but we are not taking direct sales/commercial vendors for this event. Booths may be limited to avoid repetition. Poplar Grove has the right to refuse entries. You must submit via email or mail 5 photos of your work including one of your booth set up for consideration.
- Concessions: Preserves, dips, desserts
- Food Trucks: Please fill out separate application specifically for food truck vendors available on our website. Space is limited. Whisper quiet generators only, there is no 50 amp electrical service for this event.

THIS IS A JURIED EVENT. ARTS AND CRAFT SPACES ARE LIMITED TO 75 VENDORS.

THIS FESTIVAL WILL BE LOCATED ON OUR NEWLY EXPANDED TOP LOT AND STRETCH ACROSS THE ENTIRE TOP LAWN OF THE PG. PROPERTY ON HWY 17.

BOOTH/SHOW LAYOUT: Spaces will be 10' x 10'. Booth spaces will be assigned and marked, and a layout of the spaces will be sent via e-mail on the Monday before the week of the event. Vendors may request and pay for multiple side-by-side spaces.

Vendors must provide all displays, pup tents, tables, chairs, drop cords, etc. that will be needed for the sale. You may request an electrical location if needed specifically for your product, available on a first come, first served application basis. Fans and heaters are not permitted to be plugged in to avoid overloading our system. All tents must be weighted down with appropriate weights. You are responsible for any loss or damages incurred by an improperly secured tent and/or setup.

SHOW SET-UP: Exhibits must be set up and vehicles off the lawn by 9:45 AM on Saturday & 9:45 AM on Sunday.

All vendors will receive an emailed package consisting of map, Zone location (for unloading/loading/parking), time slot for arrival, parking pass and show set up information the MONDAY AFTERNOON prior to the event.

Vendors may set up on Friday, October 28th between 1:00 pm and 5:00 pm. Please contact Suzette if you would prefer to set up on Friday.

NOTE: There will be overnight security on Saturday night, but not on Friday night. (We advise only setting your tent and tables if you choose early set up on Friday). We are not responsible for loss or damages. Poplar Grove Foundation, Inc. is not responsible for the success of your sales. Know your sales audience! This is a family-oriented local event. You may bring your vehicle in after 5:15 on Saturday (or when grounds have been cleared of guests) in order to take home your product if you do not wish to leave it overnight, there will be hours on Sunday morning to bring your vehicle in to restock/set up.

ALL VENDORS must exhibit from 10:00 AM until 5:00 PM, on Saturday, October 29th & from 10:00 AM until 4:00 PM, on Sunday, October 30th. For the safety of everyone, no one may move a vehicle on or off the grounds during event hours. You may not break down during show hours to leave early - barring an emergency. Please text Suzette at 910 998 3322 in such an event.

***WE DO PROMOTE TRICK OR TREATING WITH THE VENDORS AND LAST YEAR WE HAD A TON OF KIDS PARTICIPATING SO PLEASE BE PREPARED. THERE WAS A HUGE ATTENDANCE LAST YEAR FOR THE FIRST YEAR AND VENDOR SALES WERE RECORD BREAKING. WE KNOW CANDY COSTS MONEY THOUGH SO WE ARE KEEPING THE VENDOR FEE FOR THIS EVENT THE SAME AS LAST YEAR.

Vendors are responsible for appropriate tax ID numbers and related information. NC Dept of Revenue requires your CoR or exemption to be prominently displayed during the event.

BOOTH FEES (PLEASE CHECK NEXT TO SPECIFIED SPACE APPLYING FOR)

ARTS AND CRAFTS: You must include 5 photographs or a website link. This is a 100% HANDMADE EVENT.

-----OUTSIDE: \$85 for two days

CONCESSION VENDORS USING TENTS: \$85 (includes kettle corn, baked goods, preserves etc.), 10' x 10' space (YOU MUST SUPPLY A COPY OF YOUR KITCHEN INSPECTION OR COMMERCIAL KITCHEN USAGE)

CONCESSION TRAILERS; \$100 for 2 days. (Please fill out food vendor application so we have the details of your trailer.)

FOOD TRUCK VENDORS: \$150 – please see FOOD VENDOR APPLICATION.
