**Saturday, April 11<sup>th</sup>, 2026 • 9:00 – 5:00 pm**  
**Sunday, April 12<sup>th</sup>, 2026 • 10:00 – 4:00 pm**

**LOCATION:** On the grounds of Poplar Grove Plantation, nine miles north of Wilmington. Please come prepared for an **OUTSIDE SALE, RAIN or SHINE. Limited indoor spaces for arts/crafts vendors.**

**ACCEPTABLE ENTRIES:** Live vegetable, herb & flower plants, shrubs and trees, gardening items and accessories, herbal products, dried material, garden art, books, tools, home-based foods, local produce, home & kitchen items, select arts & crafts with a focus on nature themes/environment/recycling. Booths may be limited to avoid repetition. Poplar Grove has the right to refuse entries. Priority reserved for garden/hand-made/local items.

**BOOTH/SHOW LAYOUT:** Spaces will be 10' Width x 10' Depth for artisans and 20' Width x 10 Depth for plant vendors. Booth spaces will be assigned and marked, and a layout of the spaces will be sent via e-mail on the Monday before the week of the event. Vendors may request and pay for multiple side-by-side spaces.

Vendors may request vehicle to remain at booth site, by permission only in the *Special Consideration* space on the application. First come, first serve basis with priority on HANDICAPPED VENDORS. Booth assignments will be determined by this *Special Consideration*. Conservation efforts are underway, and vehicles create unnecessary wear and tear on the lawns and contribute to further erosion.

Vendors must provide all displays, pup tents, tables, chairs, drop cords, etc. that will be needed for the sale.

**SHOW SET-UP:** Exhibits must be set up and vehicles off the lawn by 8:30 AM on Saturday April 11<sup>th</sup> & 9:30 AM on Sunday April 12<sup>th</sup>.

**THERE WILL BE EARLY SET UP ON FRIDAY APRIL 10TH FROM 10AM TO 5PM. THERE IS NO NEED TO CONTACT US TO LET US KNOW YOU ARE COMING, IT IS ALL ACCESS AND YOU MAY UTILIZE ANY GATE ON FRIDAY. IF YOU ARE COMING ON SATURDAY YOU MUST FOLLOW THE GATE OF ENTRY AND TIME SLOT YOU ARE ALLOCATED IN YOUR SET UP PACKAGE. IT IS HIGHLY ENCOURAGED THAT IF YOU HAVE AN OVERSIZE VEHICLE, TRUCK OR ARE PULLING TRAILERS THAT YOU COME ON FRIDAY TO SET UP. IF YOU HAVE ANY OF THE ABOVE AND NEED TO SET UP SATURDAY MORNING PLEASE FILL OUT THE INFO. BELOW SO YOUR ARRIVAL TIME CAN BE COORDINATED TO AVOID TRAFFIC CONGESTION.**

**VENDOR VEHICLE TYPE AND TOW VEHICLE LENGTH:-** \_\_\_\_\_

**NOTE:** There will be overnight security on Saturday night, but not on Friday night.

**ALL VENDORS** must exhibit from 9:00 AM until 5:00 PM, on Saturday, April 11<sup>th</sup> & from 10:00 AM until 4:00 PM, on Sunday, April 12<sup>th</sup>. *Poplar Grove is not responsible for vendor sales. It is a plant sale, thus salt and pepper may not fly out of your booth. Know your product, your market, your audience.*

For the safety of everyone, no one may move a vehicle on or off the grounds during event hours.

**Vendors** are responsible for appropriate tax ID numbers and related information. NC Dept. of Revenue requires your CoR or exemption to be prominently displayed during the event.

### **BOOTH FEES**

**PLANT VENDORS:** includes live nursery plants for landscapes & garden

OUTSIDE ONLY: \$150.00, booth size 20' Width x 10' Depth

**ARTS/CRAFTS VENDORS:** includes but not limited to cut flowers, assembled gardens such as terrariums and container gardens, garden sculptures, bird houses, metal arts. **You must include 3 photographs or a website.** Commercial vendor spots are limited to returning vendors only as we are primarily a handmade/grown/produced event.

OUTSIDE: \$120.00, booth size 10' Width x 10' Depth

\*THERE WILL NOT BE ANY INDOOR AGRICULTURE MUSEUM SPOTS AVAILABLE THIS YEAR DUE TO THE MUSEUM HAVING AN ALTERNATE PURPOSE FOR THE EVENT.

**CONCESSION VENDORS:** \$120.00 (includes kettle corn, baked goods, take-away produce such as nuts, oranges, apples, etc.)

**FOOD VENDORS:** \$150.00 – please see FOOD VENDOR APPLICATION.

**NEW VENDORS, PLEASE SEND APPLICATION ONLY, NO PAYMENT UNLESS CONTACTED WITH CONFIRMATION OF ACCEPTANCE. RETURN VENDORS PLEASE SEND PAYMENT WITH YOUR APPLICATION. Applications will still be accepted until Friday, March 15, 2026 or until show is filled.**

**This show fills quickly so we recommend you get your application in as soon as possible after receiving the paperwork.**
